3. Data Storage and Security

Storage Methods

Cloud-Based Servers: Our primary method of storing your data involves the use of cloud-based servers.

Browser Cookies: For enhancing user experience and functionality, we store cookies in your web browser. These cookies help in remembering your preferences and settings, making your subsequent visits to our site more personalized and efficient. We strictly adhere to privacy laws and guidelines in our use of cookies, ensuring that your privacy is respected and protected at all times.

Security Measures

We use robust security systems to protect your account and data, this may include monitoring user data, and browser cookies to prevent unauthorized access.

Data Retention

To comply with data retention regulations, we retain personal data for specific periods depending on the type of data and the purposes for which it is processed.

- **Account Information:** Retained for the duration of the user's account activity plus an additional 5 years for audit and legal compliance.
- **Transaction Records:** Kept for 7 years to comply with financial and tax regulations.
- **User Interaction Data:** Stored for a maximum of 3 years for service improvement and analytical purposes.
- Cookie Data: Retained for up to 2 years for enhancing user experience and website functionality.

Upon expiration of these periods, or if the data is no longer needed for its intended purpose, we securely delete or anonymize the data. We may keep some data longer if we have a reasonable and legitimate interest to do so.

4. Data Sharing and Disclosure

Circumstances of Data Sharing

- **Partners:** We share data with our partners only for essential operational purposes, ensuring they adhere to our privacy standards.
- **Legal Reasons:** Data is disclosed if legally mandated or to comply with legal processes.
- **Third Parties:** Trusted third-party service providers may access data to assist in providing our services. These providers are bound by confidentiality agreements and are only given the necessary data to perform their specific functions.

5. User Rights and Choices
